About the CRP Program and Lott Industries



Community Rehabilitation Program (CRP) - Ohio Department of Administrative Services

Ohio Revised Code (ORC) 125.60 through 125.6012 ~ Ohio Administrative Code (OAC) 123:5-3-1 through 123:5-3-12

CRP: Community Rehabilitation Program is a purchasing program directed by Ohio law under ORC & OAC (codes above).

Did you Know? Prior to starting a competitive bid process, Ohio's state agencies and political subdivisions are obligated to review and buy from the "procurement list" of products & services available from CRP providers.

Easy Process: Purchases by a political subdivision are exempt from competitive bid procedures otherwise required by law and are required to be made from qualified nonprofit agencies or their agents. For details, please see: ORC Sec. 125.6011 (B) & 125.04 [Our Best Compliment: "The CRP buying process at Lott is fast and easy!"]

Order Offices: "Any state agency, incl. General Assembly; OH Supreme Court; any state authority, board, bureau, institution, commission, or instrumentality funded in total or in part by state money; and any county, township or village."

Political Subdivision: County, township, village, school district, special purpose district, commission, authority, public corporation, board, college, university, any other institution or entity supported in whole or in part by General Assembly funds.
